Love Learning Music Therapy Program. Providing music therapy in-home, at community centers, and over zoom to help children who have suffered trauma and those that have special needs to overcome the challenges they face. The objective of this program is for children served to progress developmentally through overcoming traumas, and special needs so they can become passionate pioneers of change. Service accomplishments include 256 children who have special needs &/or have suffered trauma received adaptive education and therapeutic mentorship that has helped each child to overcome some trials they face. 10 children have received one-on-one care ongoing that has contributed to their mental, emotional, and cognitive success in school and life.

4b (Code:) (Expenses \$ 34459. including grants of \$ 1350.) (Revenue \$ 51637.)

Love Learning Music Education Program. Providing music education classes that are designed and implemented in ways that improve overall development for all children, especially children who have suffered trauma and those with special needs, or any who need an adaptive approach to education. The objective of this program is for children served to receive and display authentic developmental progress. Service Accomplishments of Music Ed. include 742 children receiving Love Learning Music provided programming in partnership with other local non-profits.

Love Learning Music Resource Provision Program. Providing educational and therapy resources to children in need through partnerships with non-profits merchants schools parents and lower-income community leaders. The objective of this program is for children in need to receive the essential resources for life and education. The previous 2 programs listed would not function well without resources being provided for the children. The long-term goal is to establish partnerships that consistently meet the resource needs of all children in need within a given community. Service accomplishments for this program include 7 children receiving musical instruments, and 7 children receiving therapy and education resources.
